#### 4. FIRST-AID MEASURES

Inhalation	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. For breathing difficulties, oxygen may be necessary. Call a physician if symptoms develop or persist.

# **5. FIRE-FIGHTING MEASURES**

Suitable extinguishing media: Unsuitable extinguishing media:	Water spray, fog, CO2, dry chemical, or alcohol resistant foam. Do not use a solid water stream as it may scatter and spread fire.
Specific hazards arising from the chemical:	Fire may produce irritating, corrosive and/or toxic gases.
Special protective equipment and precautions for firefighters:	Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA. #### 6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures:	Eliminate all sources of ignition. Avoid contact with skin or inhalation of spillage, dust or vapor. Keep unnecessary personnel away. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering them.

	Absorb with inert absorbent such as dry clay, sand or diatomaceous earth, commercial sorbents, or recover using pumps.
